#### **Terms & Conditions**

Dimensional factor for Preferred LCL shipments is 1 kg. = 366 cu. inches (6,000 cu. cm.) with charges applied to the greater.

Rates subject to a minimum charge of \$250 per shipment (not including fuel surcharge, AMS fee or pickup from door to origin port).

Rates are applicable to U.S. ZIP Codes and Canadian points as specified — Toronto, Montreal, Ottawa and Vancouver only designated as A/P/B1 points.

- Delivery to B2 and B3 designated points—\$0.39/kg., minimum \$60
- A, P, B1, B2 and B3 points are defined by the current version of the UPS Supply Chain Solutions<sup>®</sup> Quick Zip program, found <u>here</u>. UPS Supply Chain Solutions service points are subject to change without prior notice.

Residential deliveries will incur an additional \$125 charge.

Lift Gate deliveries will incur an additional charge of \$7.50 per 100 lbs. (\$100 minimum/\$350 maximum).

Transit times are valid for shipments that are customs-cleared and based on UPS providing customs brokerage service at the Port of New York/New Jersey. Transit times vary depending upon destination. Transit time estimates are based on UPS providing customs brokerage service.
